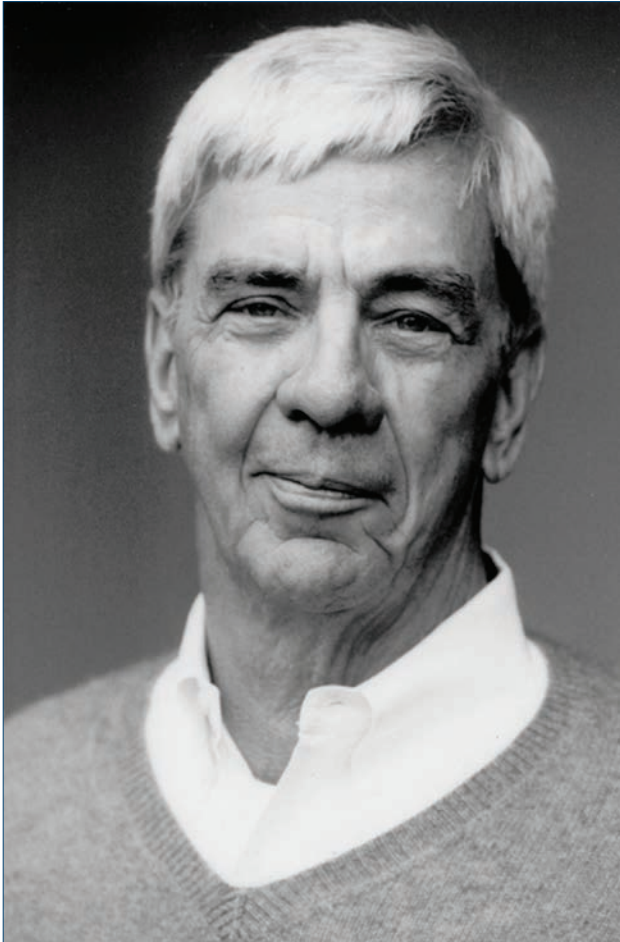

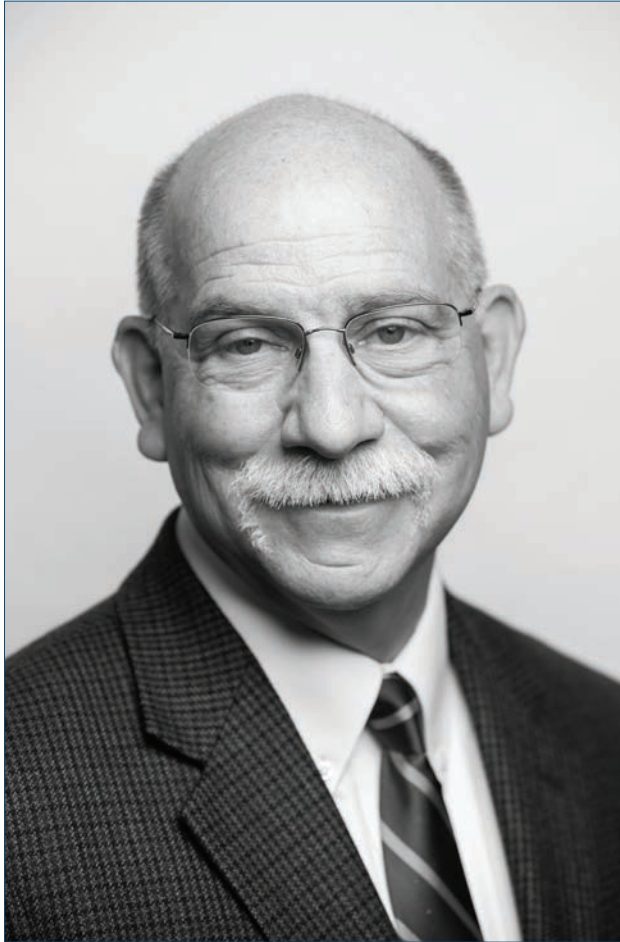

The Fund provides assistance to individuals with disabilities and their families needing to purchase assistive technology and medical devices. 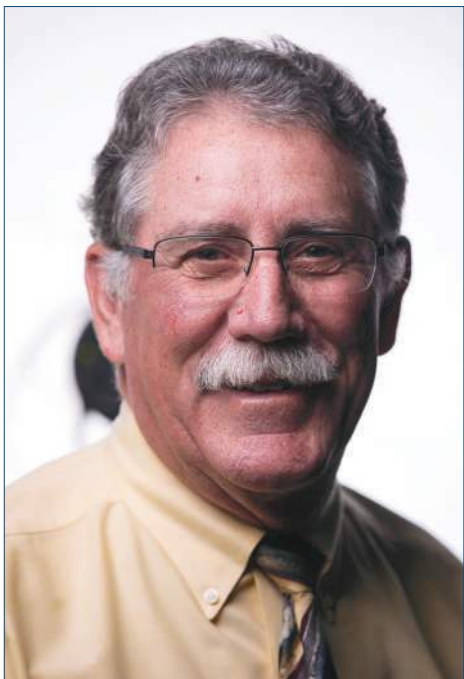

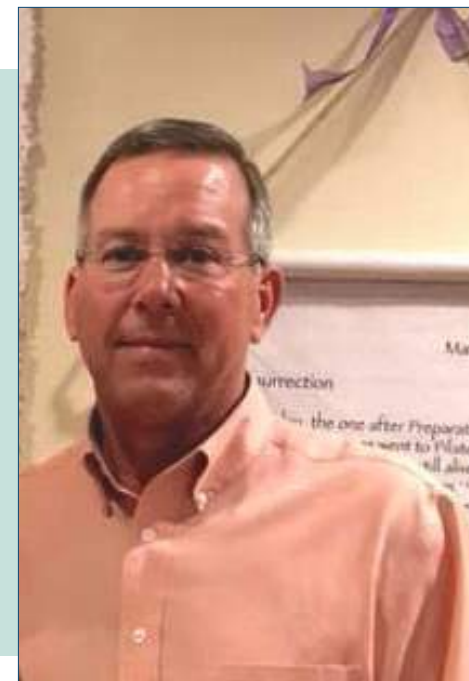
MEET OUR NEW BOARD MEMBERS

RENOVATIONS

The Timbers apartment community, constructed in the 1980s, is about to get a remodel. As seating systems and technologies change, it is important that The Timbers remains accessible. In the above photo, architects set up a cardboard model of the proposed apartment design in order to receive feedback from Timbers residents and staff regarding its functionality.

NEW PROGRAM

CPRF will be starting a one-of-a-kind program: Transitional Housing. This program will be designed for young adults with disabilities who want to live independently, but need to build their self-care skill-sets. Participants will live independently in CPRF's transitional housing for a period of a few weeks, during which time they will learn life skills such as bill paying, managing care, and more.

EQUIPMENT FUND

CPRF consolidated with United Cerebral Palsy of Kansas. This allows CPRF to provide more wrap-around services for those with disabilities around the state, in addition to the Wheelchair & Posture Seating Clinic. The Equipment Fund provides financial aid toward the purchase of assistive technology and/or medical equipment for individuals with disabilities.



Jessica is a fiercely independent 35-year-old from Parsons, KS. A naturally creative and outgoing person, Jessica runs her own craft business, selling hand-knit home goods at markets and local events.

Born with osteogenesis imperfecta, Jessica has been a client of the CPRF Wheelchair & Posture Seating Clinic since she was a young child and has used a wheelchair for safe, reliable, and comfortable mobility for decades. To her, this seating system is vital.

“It’s everything. It’s literally everything,” said Jessica. “This chair is essential to my life...my wellbeing. It makes me feel good, not isolated.”

Her hot pink chair is just like Jessica herself: unique and bright. It is tailored to her body to ensure she stays in a safe and secure position. It raises and lowers to suit various environments, and the cushions are molded to ensure she remains comfortable and that pressure points are alleviated.

Jessica relies on her chair in order to do the things she loves, whether that’s going to the movies, visiting her favorite downtown café, or even working.

WHEELCHAIR & POSTURE SEATING CLINIC

Our Wheelchair & Posture Seating Clinic addresses the needs of nearly 800 adults and children with physical disabilities every year, building custom chairs that suit the needs and lifestyle of each individual. Designed to enhance comfort, provide better body alignment, and minimize the risk of pressure sores, our seating systems range from manual chairs to intricate power wheelchairs. Physical and occupational therapists are on staff to work with each client to ensure that we build the best seating system possible. All of our wheelchair seating systems are

built in-house by technicians with decades of specialized experience. Technicians and therapists work together to ensure each client receives the best chair for their optimal mobility, comfort, and independence. Our partnerships and support from Sedgwick County, Kansas Department of Health and Environment Services for Children with Special Health Care Needs, United Way of the Plains, regional United Way organizations, and generous donations make it possible to offer the clinic as a valuable statewide resource for clients.

EQUIPMENT FUND


The CPRF Equipment Fund is a resource for people with disabilities throughout Kansas who need referral services, information, or financial assistance for medical devices and assistive technology. Through this program, CPRF creates funding packages for items such as power wheelchairs, van lifts, home modifications, video magnifiers, cranial molding helmets, ramps, lift chairs,

and much more. Many assistive equipment devices can be costly and often present a financial hardship for individuals and families. CPRF's partnerships and support from Sedgwick County, Kansas Rehabilitation Services, United Way of the Plains, regional United Way organizations, and generous donations to ensure our Kansas families receive the equipment they need.

SCHOOL OF ADAPTIVE COMPUTER TRAINING

The SACT is devoted to improving job-marketable skills for people with disabilities. In addition to our Microsoft-approved curriculum and Microsoft suite certifications, we offer courses in computing fundamentals and customer service. Our partnership with Workforce Alliance of South Central Kansas, USD 259, Mulvane School District, Haysville School District, and United Way of the Plains has allowed us to offer morning, afternoon, and summer classes for high school students with disabilities

to learn valuable workplace skills and earn Microsoft certifications in Word and Excel while earning school credit. Since the program started in 2008, 363 students with disabilities have graduated from the program and 85% have passed at least one Microsoft Certification exam. Through July 2017, 80% of graduates responding had positive outcomes of obtaining employment and/or post-secondary education.



Marie wanted her four year old son Isaac to be fully engaged in his classroom, and his school therapist suggested that CPRF might be able to help purchase a mobility device he could use in class.

Through the combined efforts of CPRF's Equipment Fund and Isaac's preschool, he is now using a mobile prone stander in the classroom. This allows Isaac to interact with the world in a way that his developing brain wants and needs.

“He wants nothing more than to just move.”

The mobile prone stander has greatly expanded Isaac's ability to learn interactively. He is able to move easily between preschool station activities, stand at eye level with his classmates, and participate in sensory activities.

Getting around in a whole new way has also allowed Isaac to become more socially outgoing. He loves music, and his prone stander has allowed him to be a part of circle time during group songs.

Marie is excited that Isaac will be able to continue to develop in an age appropriate way now that he can stand and move as he desires.

ADULT DAY SERVICES

Our Adult Day Services team ensures that each client's individual needs are met every day. With amenities such as an accessible garden in our private courtyard, a wheelchair swing, sensory room, private swimming pool, community outings, and many other indoor learning and recreation opportunities, our clients have a variety

of stimulating activities to choose from. We are able to offer these options thanks to the help of generous volunteers such as the Sedgwick County Master Gardeners, Wichita State University School of Music, United Way of the Plains, and many other community organizations. Caregivers can be confident that we provide their loved ones with excellent care.

CASE MANAGEMENT

Our case managers coordinate services for more than 100 individuals with disabilities each year, focusing on advocacy, service provision, resources, funding, and helping clients understand their rights and

responsibilities. We also offer the WORK Program through the State of Kansas, which is a service for individuals with disabilities who want to work, but still need to receive their vital health and long-term care coverage.

EXERCISE & WELLNESS

The CPRF Exercise and Wellness Program promotes fitness for people with disabilities through strength training, improving flexibility, and pain-controlling exercises. Our Certified Restorative Aide works under the direction of an occupational therapist in our private

gym on the Timbers campus. Our equipment includes parallel bars, standing frames, hand cycles, a para-gym, an elliptical, a cardio strider, and more. CPRF partners with United Way of the Plains and Sedgwick County to provide these services to those with disabilities in our area.

KANSAS WORK INCENTIVES NETWORK

KWIN provides Work Incentive Planning and Assistance services to Kansans with disabilities who want information about Social Security work incentives and community supports. In order to help people make informed employment decisions as they transition to

and/or advance in employment, KWIN clients are offered guidance, benefit analysis, and a work incentive plan by Social Security Administration-certified Community Work Incentive Coordinators. KWIN is the only Work Incentive Planning and Assistance project in Kansas.

JOB PLACEMENT

The CPRF Job Placement department guides people with various vocational barriers to the right position through resume development, mock interviews, and application and job search assistance. Through Ticket to Work, End-Dependence Kansas, and other programs, we work with people individually to ensure they find a job that suits their

career goals and abilities. Community Based Job Tryouts are also available to ensure employee retention. Our staff further assists in the job hunt by educating clients on a potential employer's expectations, changes in the job market since they were last employed, and what to expect from the jobs they seek.

VOCATIONAL ASSESSMENT

Our Vocational Assessment team administers tests to measure aptitudes, skill levels, abilities, interests, work values, and more. The results generate a variety of potential careers and/or training programs that would

suit the client. Our one-on-one approach ensures clients receive more precise employment recommendations, which can reduce job-related dissatisfaction and turnover rates.

TIMBERS APARTMENTS & TRANSPORTATION

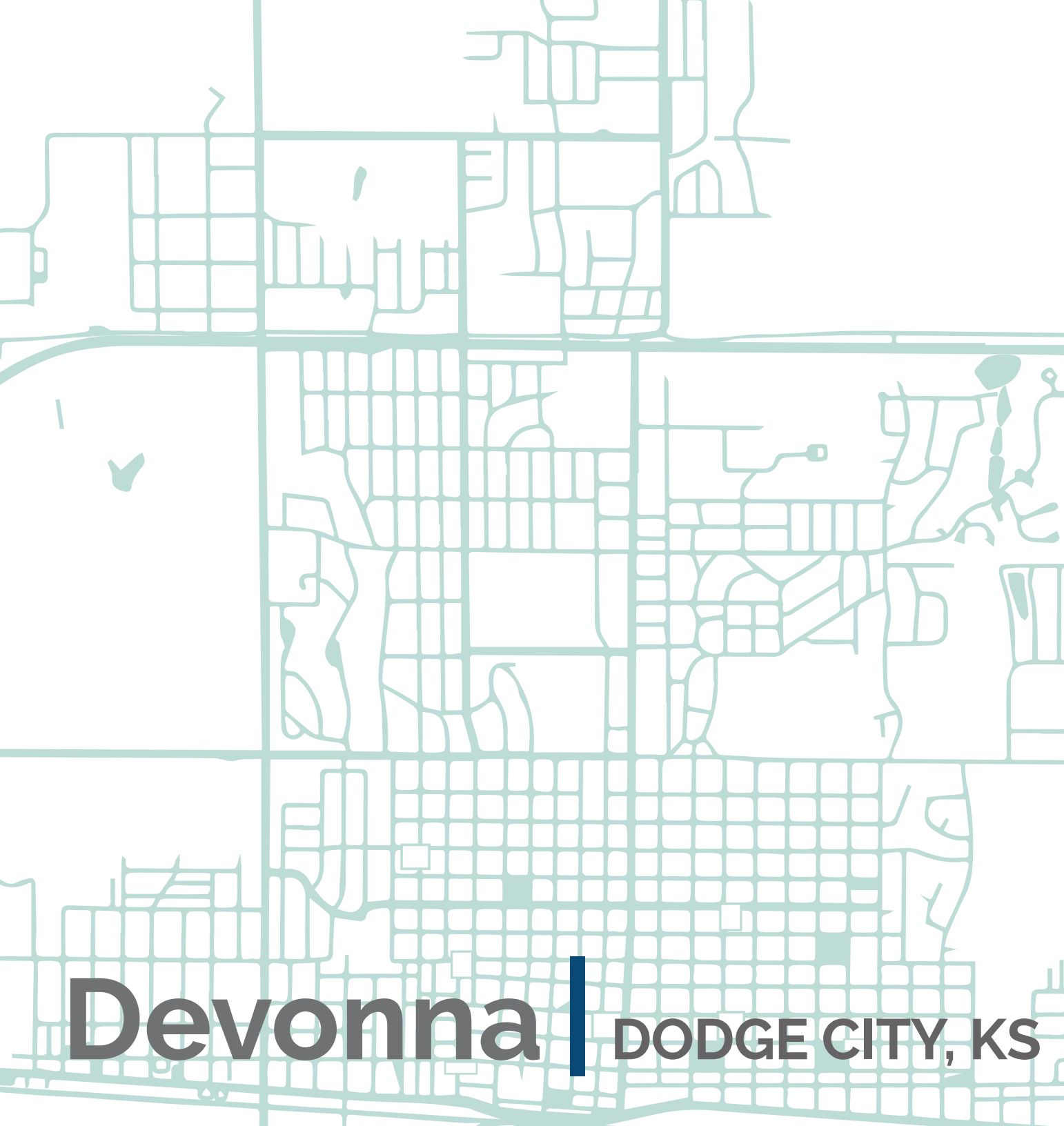
The Timbers is a 100-unit apartment community for people with physical disabilities, featuring roll-in showers, roll-under sinks and counters, accessible switches, and more. In addition to these amenities, the Timbers also has three FEMA tornado shelters throughout the campus. Our wheelchair-friendly, open concept apartments and facilities make it possible for our residents to live life how

they choose. Craft and book clubs, community guest speakers, and other engaging social activities allow residents to connect. Timber Lines Transportation provides wheelchair-accessible rides to help residents and community members keep medical appointments, go to work, and more. Timber Lines Transportation is supported by United Way of the Plains.

JANITORIAL SERVICES

The Janitorial Services program allows CPRF to offer more integrated employment opportunities for people with disabilities. This program provides part-time and full-time work with competitive wages and health benefits in the porter

and janitorial fields. Our services include: floor cleaning, trash removal, dusting, window cleaning, porter/matron services, and other routine cleaning duties. We offer flexible and reliable options tailored to the needs of any business.



Devonna received her first wheelchair from the Wheelchair & Posture Seating Clinic at two years old.

Now seven, Devonna relies on her lime green powerchair to keep up with her siblings, play sports, and enjoy the outdoors.

Devonna has muscular dystrophy, and having the ability to get around independently is a huge part of what makes her such a happy, active kid. Her mom, Ann, values the importance of her not needing to be carried or pushed in a manual wheelchair.

“She is free. I love watching her play her sports and just run around with the other kids with not a care in the world.”

Having the right chair to keep up with children as they grow is imperative to their health, safety, and comfort. Devonna relies on the Wheelchair & Posture Seating Clinic for repairs and maintenance to ensure her chair can keep up with her. She'll even be getting a new power chair through the Clinic this summer.

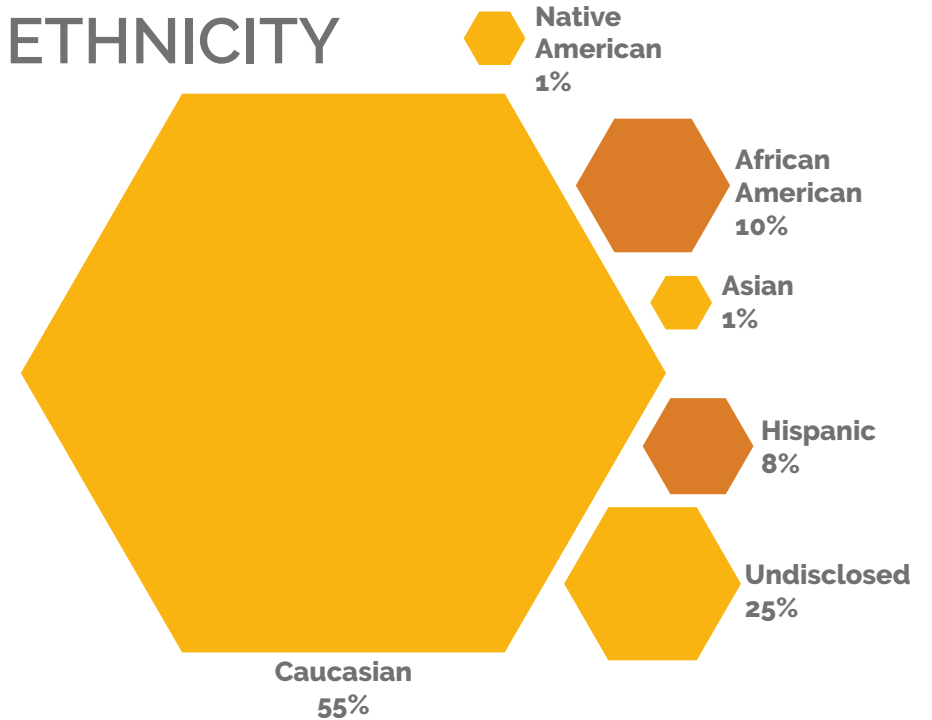

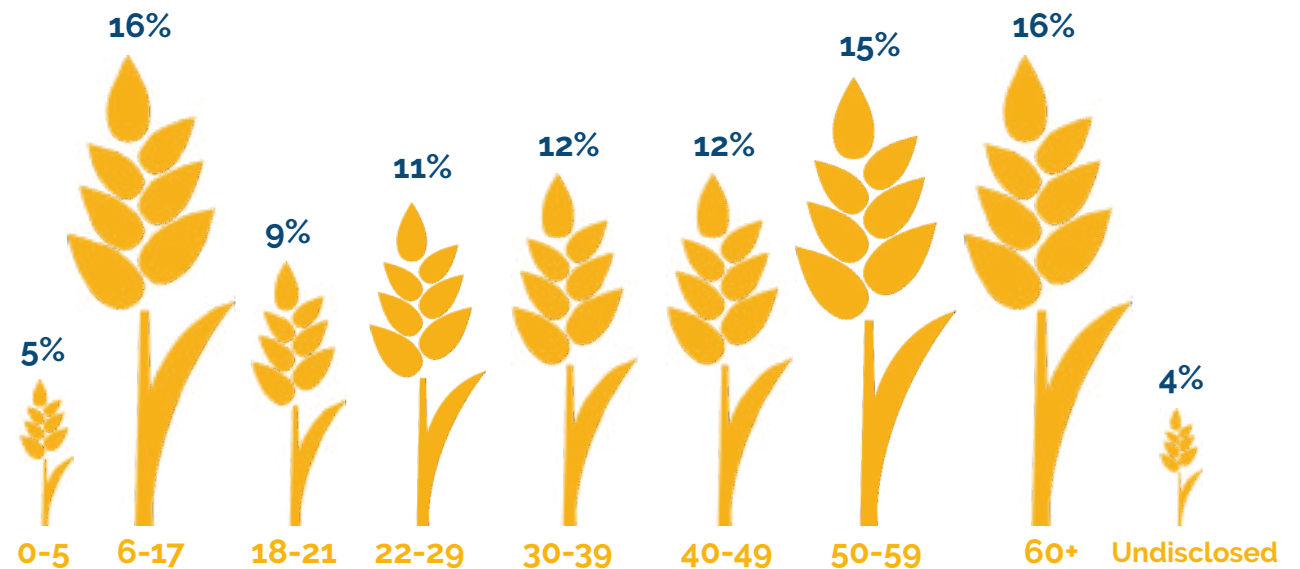

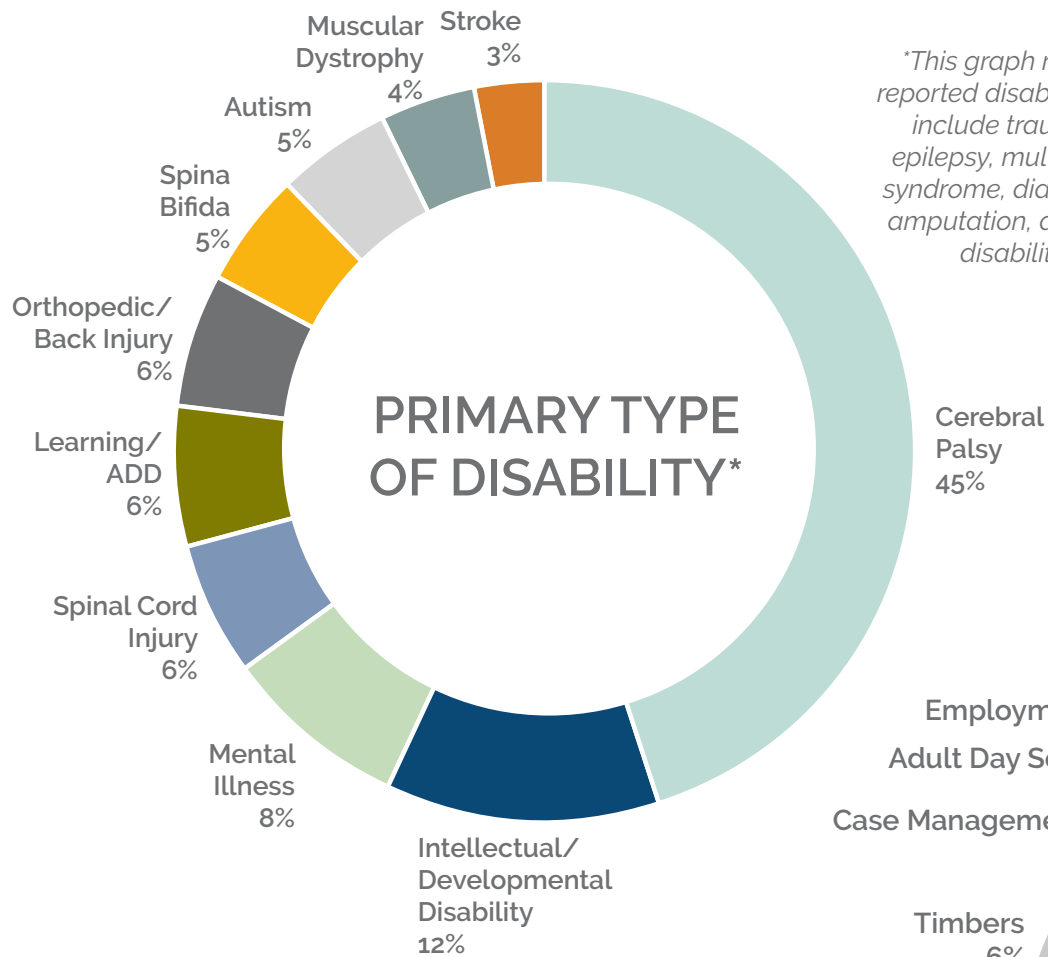

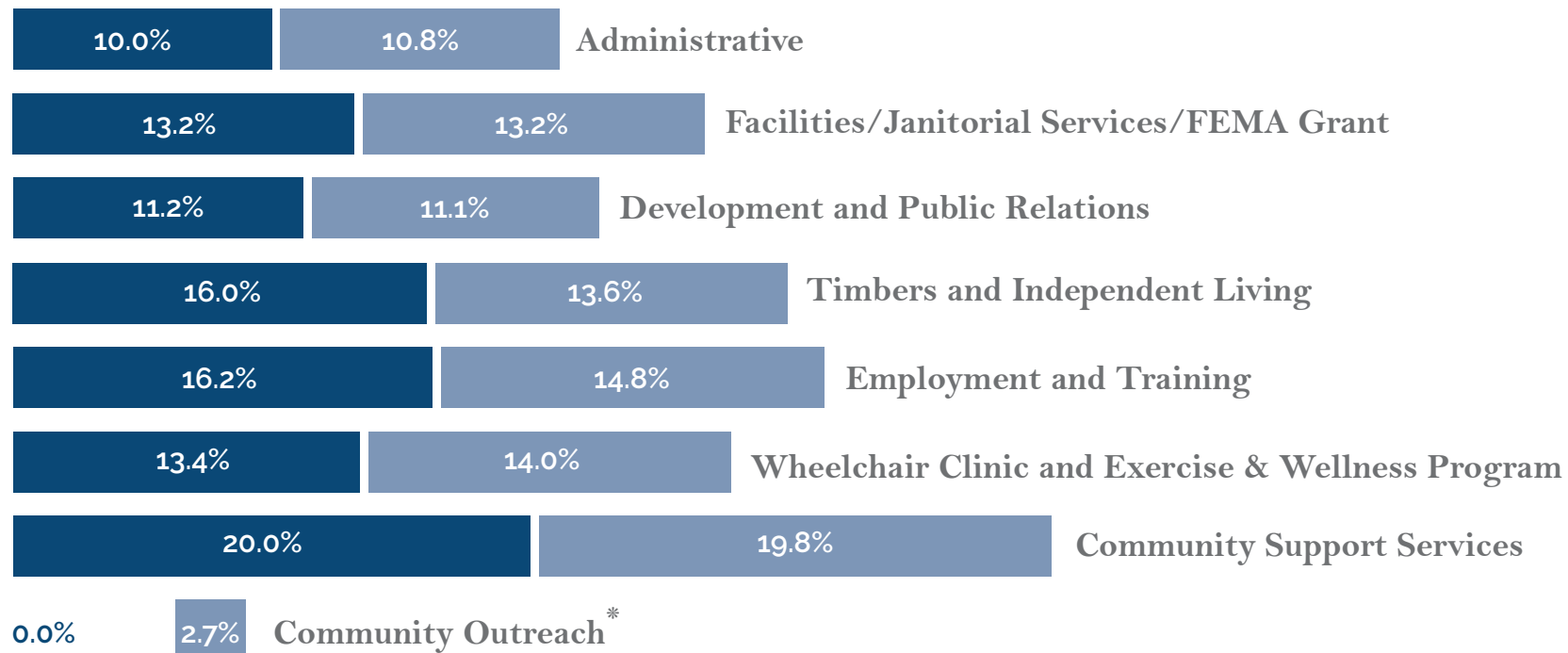

Assistive technology from CPRF is changing how Luke, who is visually impaired, experiences the world.

As Luke's vision declined, the magnifying device he used for most of his day was putting strain on his eyes. The Braille Sense Polaris tablet allows Luke to receive and input information in braille. His school assignments can then be converted into emails that can be read and replied to by his teachers and classmates.

“There are many things the Braille Sense can do that we have just begun to explore... possibilities for improvements that we don't even know about yet.”

Funding for assistive technology like Luke's tablet is difficult to come by, but through CPRF's Equipment Fund, Luke's mom, Heather, was able to obtain the tablet. Heather is excited for Luke to be able to communicate independently in all areas of his life.

A Braille Sense Polaris (pictured) is a tablet that combines braille and mainstream Android apps.





The Peter John Loux Award provides an annual recognition gift to a Kansan who demonstrates exceptional desire and dedication in overcoming their disabilities.

Any Kansas resident 18 years of age or older with a congenital or acquired physical or neurological disability may be nominated

by another person or apply on their own behalf. Each Peter John Loux Award winner receives \$1,000 and a commemorative plaque.

The award is an endowed gift established by the late Richard C. "Pete" Loux in memory of his son, Peter John. Mr. Loux, a lifelong advocate for people with disabilities, used his

influence as the Kansas House of Representatives Minority Leader to help launch Center Industries Corporation in 1975. He also served on the CPRF Board of Directors from 1972-2004.

Born with cerebral palsy, Erlena has used a wheelchair since kindergarten. Throughout the many challenges and losses life has presented her, Erlena's mantra has been to maintain a positive attitude and in her words: "Just take it one day at a time".

Erlena has been a dedicated employee at The Great Plains Nature Center for 22 years. She began her tenure as a volunteer, working 40 hours a week as a receptionist. Initially, her husband Jeff provided transportation for her to and from work. When Jeff passed away, her faithful companion and service dog, Yule, joined her on her morning commute as she continued to

make the trip to work each day in her wheelchair. She is there, rain or shine, and values being able to come to a job she loves. As someone who is always willing to help with special events or projects, Erlena has been invaluable to the nature center.

Being in a wheelchair for 20 hours at a time is part of Erlena's daily routine. But the mobility her power chair has provided proves vital to Erlena's independence in all aspects of life, not just traveling to work. If errands, appointments, or community events are located within a 4-5 mile distance, she's known to enjoy making those trips on her own.

Erlena has experienced profound loss in her life, with the unexpected deaths of her husband and father within just a few months of each other. Both of these men were a great source of strength and support for Erlena. Her father taught her to live graciously and be thankful for the

experiences and people she has met throughout life. The house that Erlena still lives independently in was built by her father. She and her husband opened their home over the years to several foreign exchange students, taking trips with them to attractions around the country. Some of these students still remain in touch with Erlena today.

According to those who nominated her, Erlena is an exceptional example of kindness, resilience, and ambition.

Surrounded by her family, friends, and the whole CPRF team, Erlena received a check and a commemorative plaque for \$1,000 at an awards banquet.

ABOUT THE JACK JONAS FOUNDER AWARDS

Jack Jonas, CPRF Founder, dedicated his life's work to serving and advocating for an underrepresented population, creating an organization based around the principle that everyone, regardless of their physical abilities, has the right to an education, a career, and independence.

In honor of Jack's legacy and spirit, CPRF established the Jack Jonas Founder Awards to recognize three

employees per year who have shown dedication to the CPRF mission and who truly have a heart for those we serve.

The award winners are announced at CPRF's annual holiday luncheon and receive a commemorative plaque and a check for \$1,000 each.

All CPRF, CIC, and BTCO employees are eligible for the award.

Because using her extremities to control her wheelchair wasn't feasible, CPRF OTs and fabrication technicians built Colette a chair with a head array system that allows her more control over her movements.

"It's given her the freedom to move about on her own and engage in the world on her own without having the need for assistance every second of the day."

Her chair is also vital to her learning experience at school because it connects to a tablet that she uses to complete her schoolwork and engage in the classroom with her fellow students.

Her dad couldn't be more thrilled with the amount of independence she now has.
